2. The terms of reference of the said Committee would be as follows:-

- a). The Members of the said Committee would be responsible jointly and severally to take steps to stop ragging in the Institute.
- b) The Committee should interact with the students of 10<sup>th</sup> Batch and take them in confidence by apprising them of their right as well as obligation to fight against ragging and to generate confidence in their mind so that any instance of ragging to which they are subjected or which comes to their knowledge should forthwith be brought to the knowledge of the Committee and the same shall be promptly dealt with.
- c) The Members of the Committee are empowered to visit any place in the campus including the rooms of hostel at any point of time during day

and/or night, in order to keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.

d) The Committee shall undertake regular survey of the entire first year batch to find out if any sort of ragging is taking place in the campus of the Institute and submit a weekly report to the Dean, with a copy to Director.

e) In case of any incident of ragging, the Committee would forthwith investigate into the matter and submit a report to the Dean, with a copy to Director.

f) The Committee is empowered to summon any student, employee, faculty member and person to depose before it.
