No. 8 of this tender.
2.	Tender will have to be submitted only on the numbered "Tender Paper" issued by SRFTI. Each page of the "Tender Paper" should be signed by the authorized signatory of the firm.
3.	Tender should indicate the 'total rate each item' on FREE DELIVERY OF MATERIALS AT SITE basis and shall be INCLUSIVE OF ALL APPLICABLE TAXES, OCTROI AS WELL AS INSTALLATION COST.
4.	The successful tenderer shall have to deposit 5% of the total value quoted as Security Deposit through banker's cheque /Draft drawn in favor of "Satyajit Ray Film & Television Institute" payable at Kolkata, which will be retained by SRFTI without interest, for one year after completion of the project work.
5.	Delivery of the materials and job must be completed in full within 30 (Thirty) days of the placement of the formal order.

7.	a) Documentary evidence is to be provided indicating that the tenderer is authorized distributor/ authorized dealer/ authorized sales & service agent of the OEM.(M/s Systemax). b) Proof of experience in supply of similar type of work at least three organization. c) Valid Sales Tax Clearance Certificate /VAT Registration No.
8.	Any dispute arising out of the order of the purchase shall be subject to the exclusive jurisdiction of Court in Kolkata City only.
9.	Sealed envelope containing quotations should be superscribed with the words: "EXTENSION OF LAN IN ANIMATION DEPARTMENT"
10.	Tendered rate should remain valid for at least 3 months from the last date fixed for submission of the tender. Institute reserves the right to reject part and Incomplete Tender.
