ORDER

Pursuant to the order of Hon'ble Supreme Court of India, a fresh Anti Ragging Committee has been constituted comprising the following members to tackle any issue related to ragging within the campus:

4. Smt. Rita Lee Hostel Caretaker (Girls) Member
5. Mr. Goutam Das Hostel Caretaker (Boys) Member
6. Mr. Akshay Gouri President, Student Body Member
7. Miss Nairita Thakurata Editing Student Member
8. Mr. B.D.M. Ambedkar, I.I.S., Registrar **Member Convener**

2. The terms of reference of the said Committee would be as follows:-


- (a) The Members of the said Committee would be responsible jointly and severally to take steps to stop ragging in the Institute.
- (b) The Committee shall arrange measures for interaction with the students' of the 15th Batch to take them in to confidence by apprising them of their rights as well as obligations to fight against ragging and to generate confidence in their minds so that any instance of ragging to which they are subjected to or which comes to their knowledge should forthwith be brought to the knowledge of the Committee and the same shall be properly dealt with.
- (c) The Members of the Committee are empowered to visit any place in the campus including the rooms of the hostel at any point of time during day and/or night, in order to keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
- (d) The Committee shall arrange to undertake regular surveys to find out if any sort of ragging takes place in the campus of the Institute. The Committee will be assisted by the Anti-ragging Squad for surveillance and monitoring of anti-ragging measures.
- (e) The Committee is empowered to summon any student, employee, faculty member and person to depose in front of it.

3. An anti-ragging squad comprising the following officials is constituted for keeping strict vigil within the campus to report on all matters relating to ragging and to take all steps for prevention of this criminal offence:-

3. Ms. Madhavi Tangella, Asstt. Prof. DSPW
4. Smt. Rita Lee, Hostel Caretaker
5. Shri Goutam Das, Hostel Caretaker
6. Shri Kalhan Raina, Sound Student
7. Miss Shreya Rawat, PFT Student

4. Willing representatives from parents of any student, NGOs and any other Civil Authorities may also be co-opted as members, subsequently.

It is notified that anybody caught ragging any student is liable to the strict of punishment including expulsion/rustication. This issues with the approval of the competent authority.
