

DECLARATION /UNDERTAKING FROM THE STUDENT

2. That the entries made by me in the Application Form are complete and true to the best of my knowledge and based on records.
3. That I shall at all times promptly present all original documents immediately upon demand by the concerned authorities of the Institute.

That I shall at all times and without fail religiously abide by the applicable rules and regulations, concerning discipline, attendance, etc. of the Institute (SRFTI), and also to follow the Code of Conduct prescribed for the Students of the Institute, as in force from time to time and subsequent changes/modifications/amendment made thereto. I acknowledge that, the Institute has the authority for taking punitive actions against me for violation and/or non-compliance of the same.
4. That I understand that, 75% attendance in classes is compulsory and I commit myself to adhere to the same. I also understand that in case my attendance falls short, for any reason, the competent authority of the Institute may take such punitive action against me, as may be deemed fit and proper.

That I will neither join in any coercive agitation/strike for the purpose of forcing the authorities of the Institute to solve any problem, nor will I participate in any activity which has a tendency to disturb or is otherwise prejudicial to the peace and tranquility of the SRFTI campus and/or its Hostel premises.
6. That I shall neither indulge in, nor tolerate ragging, in any form, even in words or intentions, and I promise to give an undertaking in the prescribed format to that effect.
7. That I am fully aware and do accept that as per rules and regulations of the Institute, I will not be permitted to possess or use any motorized vehicle inside the Institute campus, unless I am permitted to do so by a written prior authorisation from the Registrar.

8. That I shall be solely responsible for my involvement in any kind of undesirable / indisciplined activities outside the campus, and shall be liable for punishment as per the law of the land. I understand that the Institute shall in no way provide any support to me and will not be held responsible for my any such action.
9. That I am not suffering from any serious/contagious ailment and/or any psychiatric / psychological disorder.
10. That I am fully aware that my admission may be cancelled at any stage if I am found ineligible and/or the information provided by me are found to be incorrect.
11. I, hereby undertake to That I shall forthwith inform the Institute about any changes in information submitted by me, in the Application Form and any other document(s), including change in addresses and phone nos. etc..
12. That I understand that I do not have any claim for any non-academic programme on the campus.
13. That I also understand that no financial support will be provided to the students for any health related issue.
14. That I shall not be a cause for any academic delay for any reason on the earth.
15. That I will use only the official language and formal behavior on the campus and any deviation from this will call for rustication from the Institute.
16. That I understand that I am not in a position to ask for any clarification/justification/explanation from the authority. Any deviation from this will call for stern action against me.
17. That I shall remain responsible for paying the financial penalty (if any), other charges and fees, on time, which are reviewed / revised time to time by the Institute.
18. That I also understand that use of narcotics, consumption of alcoholic beverages and gambling are strictly prohibited on the campus; use of audio equipment in hostels/ campus is acceptable only if it is not objectionable to other residents between 10 am and 10 pm.
19. That I shall never be involved, either directly or as an abettor, in activities amounting to sexual harassment of women. I am fully aware and do clearly understand that if I am found guilty of such activity, I shall be liable for the harshest punishment that may be awarded to me by the Institute authorities.
20. That I shall diligently and honestly abide by the Hostel Rules. I am aware that any contravention of the said rules shall render me liable for such strong disciplinary action as may be deemed fit by the institute authorities as may and I shall be bound to accept the same
