### EXECUTED BY STUDENT AND RESPECTIVE GUARDIAN IN FAVOUR OF SATYAJIT RAY FILM AND TELEVISION INSTITUTE, KOLKATA

KNOW                                      ONE                      AND                      ALL                      BY                      THESE                      PRESENT                      THAT

student" (which expression shall unless excluded by or repugnant to the context, include his/her heirs,  
administrators and assigns)                      AND

\_\_\_\_\_ hereinafter called "the guardian" (which expression shall unless excluded by or repugnant to the  
context, include his/her heirs, administrators and assigns) of the student, unconditionally and  
unequivocally bind ourselves jointly and separately to abide by the rules, regulations & directives of  
Satyajit Ray Film and Television Institute, Kolkata hereinafter referred to as SRFTI.

We clearly understand that although the student has been selected for Three/Two year Course offered  
by SRFTI his/her studentship shall take effect only after this bond, duly executed and signed by both of  
us, is received by SRFTI and shall continue for 3/2 years unless his/her studentship is terminated and  
his/her name is struck off the rolls of SRFTI on the happening of any of the following—

- i) if the student is found NOT FIT for the curriculum as adjudged on the basis of  
the 1<sup>st</sup> year ending assessment made with reference to requisite academic  
stipulations of SRFTI;
- ii) if the student fails at 2<sup>nd</sup> and/or 3<sup>rd</sup> year ending assessment made with  
reference to requisite academic stipulations of SRFTI including completion of  
project work;
- iii) if the student is debarred from the year ending project because he/she has  
NOT FULLFILLED the required current percentage of attendance;
- iv) if the student develops physical weakness and/or falls sick frequently/  
regularly and in the opinion of SRFTI he/she is NOT FIT for the strenuous  
curriculum;
- v) if the student is found guilty of serious indiscipline leading to his/her expulsion  
from the Institute;
- vi) if the student discontinues the course on his/her own volition;
- vii) if the student is at any time found to have breached or violated any of the  
condition of this bond, the decision of SRFTI in this regard shall be final and  
binding.

We understand admit and accept without any doubt or confusion that SRFTI is a public Institution and its employees are public servants and the training in SRFTI is based on highly precious, sensitive and fragile equipment, and it is obligatory that the student will handle the same most carefully by taking all precautions and preventive measures in the required manner such that there is no damage, destruction or loss of equipment in his/her use.

That by these present we, the student and the guardian jointly indemnify SRFTI against any and every damage/destruction/loss/injury of equipment/property/personnel and that we bind ourselves to the consequential recovery/replacement of / compensation for any and every damage/destruction/loss/injury in the manner as assessed & directed by SRFTI.

That we jointly declared and acknowledged that the details of the existing syllabus, infrastructure, manpower and network of the Institute (SRFTI) have been comprehensively explained to the student in a lucid manner during Orientation course , and that the student herein unmistakably understood that the Institute (SRFTI) may change the syllabus, infrastructure, manpower or network in future at its discretion and he/she(student) shall never have or raise any issue to such changes. That the student shall not demand or request for anything which may be construed by SRFTI as irregular and unlawful.

That we are aware that this course is funded from the public exchequer and a student has to maintain pecuniary discipline as applicable for academic institution and accordingly we undertake to pay fees, fines and other financial obligation arising out of any reason whatsoever and also to settle or adjust advances, refund or replenished any money of the institute lying in excess with the student on any account..

That we both are aware that the nature of work in this course is highly strenuous and stressful and hazardous and in some cases potentially fatal, hence it is mandatory for the student to be mentally and physically fit and sound.

We further declared, undertake and assured that the information to be submitted before admission by the student in this present regarding medical fitness shall be comprehensive and correct and we shall not suppress any factual material/information. In case any suppression/infirmity/falseness of information is noticed at any stage/time by SRFTI Authorities, the student shall be liable to be disqualified and /or terminated, and both the student and the guardian shall be liable for legal action.

We, the student and the guardian, jointly and individually promise that the student shall, during the entire tenure of his/her studentship of the Institute, do nothing which can be translated by the Institute as an act of indiscipline or misbehavior or misconduct or otherwise can bring disrepute the Institute. We further undertake to abide by the code of discipline and conduct as required by the Institute. We confirm that we shall accept ungrudgingly any action that may be taken by the Institute against the student for breach of this above promise.

We the student and guardian jointly and unequivocally indemnify the Institute and its authorities at all times against all liabilities and consequences if by any irresponsible conduct or activity within the campus, in contravention of my declarations and promises as above, I cause any serious or fatal injury to myself or to any other student or students, resident or nonresident or to any other person or persons. In any such eventuality, The student shall be singularly responsible and liable for any action taken either by the Institute, or by a court of law or by any authority responsible for maintenance of law and order.

Provided always and it is hereby agreed and declared that, the decisions of SRFTI as to whether the student has or has not performed and observed the obligations and the conditions herein before recited, shall be final and binding on both the student and the guardian herein.

Provided also that SRFTI shall have the absolute liberty without prejudice to this bond, to postpone for any time and from time to time, any of the powers exercisable by it against the student and either to enforce or forebear any of the conditions of this bond;

Provided nevertheless that the guardian shall not be released from the liabilities/obligations under this bond by any exercise of the aforesaid liberty with reference to the matters/conditions herein before recited, or by reason of time being given to the student or any other indulgence or forbearer act of omission on the part of SRFTI, or by any variation in the terms and conditions of this bond or the offer letter whether with or without the knowledge or consent of the student &or guardian or by any other manner /matter whatsoever which under the law shall, BUT FOR THIS PROVISION, have the effect of so releasing the guardian from his/her such liability nor shall it be necessary for SRFTI to sue the student before suing the guardian for amount due hereunder;

Provided further that this bond shall in all respect be governed by the law(s) in India.

We, the student and the guardian, hereby declare that we have read and understood the foregoing content of this bond and have consciously put our respective hands the day and the year herein under written.
