
Sir,

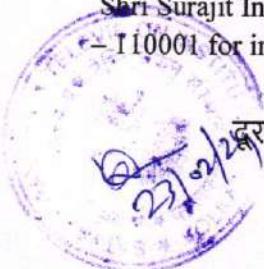

- vii) Three students' representatives (elected members)


2. The above Committee will start functioning with immediate effect after students' representatives get elected and shall have a tenure of 3(three) years.

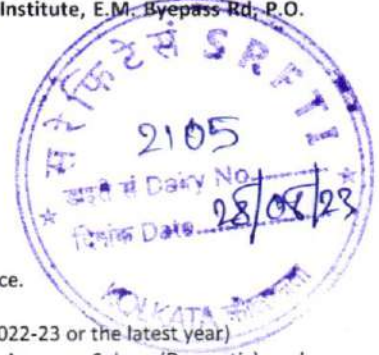



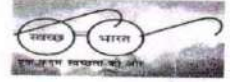
