- v) Ms. Alice Kumari, Hindi Typist, SRFTI Member
- vi) Smt. Amrita Dasgupta, a member of SWAYAM (NGO) External Member

vii) Three students' representatives (elected members)

2. The above Committee will start functioning with immediate effect after students'representatives get elected and shall have a tenure of 3(three) years.

- Mandate of the above Internal Committee are as under :
  - a) The Committee shall function as per Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 and Government of India Orders issued in this respect from time to time;
  - b) The Committee shall review the programmes and monitor implementation of development schemes for women in accordance with the guidelines suggested by the National Commission for Women;
  - c) The Committee shall initiate further action regarding Gender sensitization and Orientation;
  - d) The Committee shall take steps towards Crisis management and mediation;
  - e) The Committee shall hold Enquiry, as and when required for redressal of grievance, if any;
  - f) Any aggrieved person can approach any one of the abovementioned members at any time.

4. Further, the existing IC will continue to function dealing with cases where both the parties are staff members of this Institute, henceforth.
