3. Ensure alignment with the provisions of NEP 2020, particularly with regard to credit recognition, academic mobility, and quality standards.
5. Submit its recommendations to the Vice Chancellor, SRFTI within a reasonable timeframe.
6. Maintain proper records of deliberations and decisions for transparency and audit purposes.

**3. General:**

The Committee shall function in accordance with the above mandate. Its recommendations shall be advisory in nature and shall not attain finality unless approved by the Competent Authority.
