Subject: CLARIFICATION REGARDING APPLICATION OF RESERVATION POLICY IN ADMISSION PROCESS – 2026

This is for information of all concerned that admissions to various programmes of Satyajit Ray Film & Television Institute (SRFTI), Kolkata and Film & Television Institute, Itanagar Campus for the Academic Session 2026 are conducted in accordance with the reservation policy of the Government of India and the extant instructions issued by the Government of India from time to time.

The reservation of seats for Scheduled Castes (SC), Scheduled Tribes (ST), Other Backward Classes (Non-Creamy Layer) [OBC-NCL], Economically Weaker Sections (EWS), Persons with Benchmark Disabilities (PwBD), and other categories, wherever applicable, is provided strictly in accordance with the applicable Government of India norms.

For the purpose of preparation of the Final Merit List after completion of all stages of the admission process, the following procedure is followed:

1. A candidate belonging to a reserved category who qualifies for the Final Selection Test in the Unreserved (UR) category on the basis of merit shall be considered against both the Unreserved (UR) category and his/her respective reserved category, subject to his/her position in the final merit list.
2. A candidate belonging to a reserved category who qualifies for the Final Selection Test only under the respective reserved category shall be considered for admission against the seats earmarked for that reserved category on the basis of the final merit list.
3. Allocation of seats is carried out strictly in accordance with the final merit list, the applicable reservation policy of the Government of India, and the availability of seats under the respective categories.

This clarification is being issued to ensure transparency and to address queries received from candidates regarding the admission process. It may be read along with the Admission Notification, 2026 and other admission-related instructions issued by the Institute. In case of any inconsistency, the applicable Government of India rules, as amended from time to time, shall prevail.
