1. Regarding request for withdrawing the suspension order of Shri. Ashay Kumar

On 29.05.2024, Shri. Ashay Kumar, student, (20th batch, SRD) was given suspension order due to his involvement in a physical violence with a fellow student Shri. Abhijeet Mohanty (20th batch, SRD) and in the Dean's Council meeting it was decided that he will be suspended till inquiry is completed. Also, he was debarred from entering the campus till inquiry is completed.

In this regard, the said student has sent an email on 31.05.2024 stating that the complainant Shri. Abhijeet Mohanty has withdrawn the case from police station and both of them have mutually sorted out the issue in the police station. Hence, the student requested for the suspension to be withdrawn since the matter has been sorted mutually. The matter was forwarded to the Grievance Committee and the Grievance Committee has stated that as both the students have figured out the matter mutually and also there is no official complaint exists; the case has not been taken up by the Grievance Committee.

After going through all the papers, the members of the Dean's Council recommended that the suspension order against Shri. Ashay Kumar may be revoked, but due to his indiscipline and violation of rules and regulations of the Institute, he may be placed under 'Conduct Probation' for 1 year as per by laws clause no - 3.3.1. It was also recommended that after completion of 1 year, the Dean's Council members would do an assessment on his conduct and discipline within this period. The Proctor and guardian of the student may be notified about the same.

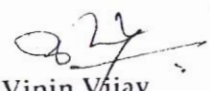
Further, it was also recommended that the student might be asked to visit institute's psychologist for counseling. In this regard, a fitness certificate may also be asked from the student. This may be issued to the student after approval from the Competent Authority.

2. Regarding request for rescheduling classes of 20th batch that they missed due to protest

The student of 20th batch has sent an email on 06.06.2024 regarding rescheduling of classes that they missed due to protest from 20th May to 06th June 2024. In this regard, members of the Dean's Council recommended that those classes, which have not been taken during that period, might be taken. But those classes where some students attended and attendance was accorded will not be repeated.

3. Constituting legal cell at SRFTI

It was observed by the Dean's Council members that there are so many administrative / legal challenges faced by the Faculty members. As they are not trained or capable enough to deal those matters, it was recommended that a legal cell might be formed by the Institute to support the faculty members to deal with such issues.

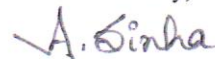

1. Regarding request for withdrawing the suspension order of Shri. Ashay Kumar

On 29.05.2024, Shri. Ashay Kumar, student, (20th batch, SRD) was given suspension order due to his involvement in a physical violence with a fellow student Shri. Abhijeet Mohanty (20th batch, SRD) and in the Dean's Council meeting it was decided that he will be suspended till inquiry is completed. Also, he was debarred from entering the campus till inquiry is completed.

In this regard, the said student has sent an email on 31.05.2024 stating that the complainant Shri. Abhijeet Mohanty has withdrawn the case from police station and both of them have mutually sorted out the issue in the police station. Hence, the student requested for the suspension to be withdrawn since the matter has been sorted mutually. The matter was forwarded to the Grievance Committee and the Grievance Committee has stated that as both the students have figured out the matter mutually and also there is no official complaint exists; the case has not been taken up by the Grievance Committee.

After going through all the papers, the members of the Dean's Council recommended that the suspension order against Shri. Ashay Kumar may be revoked, but due to his indiscipline and violation of rules and regulations of the Institute, he may be placed under 'Conduct Probation' for 1 year as per by laws clause no - 3.3.1. It was also recommended that after completion of 1 year, the Dean's Council members would do an assessment on his conduct and discipline within this period. The Proctor and guardian of the student may be notified about the same.

Further, it was also recommended that the student might be asked to visit institute's psychologist for counseling. In this regard, a fitness certificate may also be asked from the student. This may be issued to the student after approval from the Competent Authority.

2. Regarding request for rescheduling classes of 20th batch that they missed due to protest

The student of 20th batch has sent an email on 06.06.2024 regarding rescheduling of classes that they missed due to protest from 20th May to 06th June 2024. In this regard, members of the Dean's Council recommended that those classes, which have not been taken during that period, might be taken. But those classes where some students attended and attendance was accorded will not repeated.

3. Constituting legal cell at SRFTI

It was observed by the Dean's Council members that there are so many administrative / legal challenges faced by the Faculty members. As they are not trained or capable enough to deal those matters, it was recommended that a legal cell might be formed by the Institute to support the faculty members to deal with such issues.
